The procurement will be conducted through Open National competitive procurement using Request for Proposals (RFP) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" July 2016 updated September 2023 ("Procurement Regulations") and is open to all eligible Proposers as defined in the Procurement Regulations.
- 4. Interested eligible Proposers may obtain further information from National Forestry Authority and inspect the RFP document during office hours from 08:30a.m to 05: 00p.m (Monday to Friday) at the address indicated in No.9.

The RFP document in English may be purchased by interested eligible Proposers upon the submission of a written application to the address below and upon payment of a nonrefundable fee¹ of **UGX 100,000 (Uganda Shillings One Hundred Thousand Only).** The method of payment will be by Bank Payment Advice Form obtainable from National Forestry Authority. The document will be collected upon presentation of proof of payment from the address indicated in No.9.
- 6. Proposals must be delivered to the address below indicated in No.9 on or before at 11:00am on or before 28th August, 2024. Electronic procurement will not be permitted. Late Proposals will be rejected. The outer Proposal envelopes marked "ORIGINAL PROPOSAL", and the inner envelopes marked "TECHNICAL PART" will be publicly opened in the presence of the Proposers' designated representatives and anyone who chooses to attend, at the address below indicated in No.9 at 11:05am. All envelopes marked "FINANCIAL PART" shall remain unopened and will be held in safe custody of the Purchaser until the second public Proposals opening.
- 7. All Proposals must be accompanied by a Proposal Security of UGX; 2,479,000 (Uganda Shillings; Two Million Four Hundred Seventy Nine Thousand Only).
